What is the MPQC Ocard?

It is a contactless carding system that can hold all MPQC achievements gained by an individual; meaning there will no longer be a need for you to hold multiple cards to prove competency when entering sites. MP Connect is the programme used to view these achievements.

What are the Benefits of the MPQC Ocard?


As well as no longer needing to carry multiple cards or certificates to prove competency the other benefits of the MPQC Ocard are:

- Your card is automatically updated with the results of training or assessments so you no longer need to wait to receive an updated card
- When a site scans your card they will instantly be able to see if you have met the requirements to enter, speeding up the process of site access
- You will have access to e-learning created exclusively for MPQC Ocard holders to help maintain competency within your job role
