Vehicle inspections

Check Proof is Heidelberg's approved vehicle auditing app

Recent vehicle inspections have flagged a number of safety concerns:

- Side scan not functioning correctly
- CCTV haulier unable to operate and/or download footage at request
- Audible vehicle turning left on indicator

Please check your vehicles for safety compliance!

A full vehicle safety spec list is available from your DRM

Progress report:

As you maybe aware, more and more of our sites are now scanning MPQC cards on entry.

You can also 'Check-In' on the MP Connect app, downloadable through Apple and Android. The app will also be added to your Track IT tablet in due course:

Official go live date: June '25

Do not get caught out! MPQC subscription is mandatory, with out this, entry to our sites will be refused.

You will need to contact MPQC and subscribe (MP CONNECT - 01158600155)This will then enable us to review information on the card.

Each driver will be required to comply in 3 areas:

- MPQC subscription
- Site induction
- MPQC card/course in date

Site inductions are available from plant weighbridge, DRM, drivers' webpage (listed below) and now on the Track It tablet under 'Training' app.

As you may be aware, vehicle footage can prove to be invaluable during incident investigations.

Over time your local DRM we will be requesting footage at random. This will highlight any CCTV issues amongst the fleet and can be addressed accordingly.



Vehicle Downtime

Please remember to book-in any vehicle downtime with the distribution team in advance:

- · MOT's
- Services
- Driver Holiday
- Any other instance that would result in a franchise vehicle being off the road.

A 3-days' notice period is required, in order for planning to accommodate service.
