Alcohol plays a factor in 1 in 4 workplace incidents. Alcohol reduces judgment, coordination, sensory perception, reaction times and eyesight.

Drug use can increase the risk of an accident by 50%

### Prescribed and over the counter medication:

Discuss with GP/Pharmacist/ operator - complete a medication disclosure form

### **Drug and Alcohol testing:**

- Breath test is taken
- Urine sample is taken
- Individual to provide medication details

- If both results are negative, the individual returns to their duties
- If either result is 'non-negative' Heidelberg will follow process and raise with the relevant department for further action
- Test refusal will be deemed as a fail




## **Artic Vehicle Incident**
